HIGHLIGHTS: FOOD SECURITY

Supplemental Emergency CalFresh Benefits Advocacy Letter [LINK]

- a.The emergency CalFresh benefit allotment that was established during the pandemic is set to expire on February 28th (with the last benefits being disbursed in April). Over 5 million households in CA will be impacted and experience an average loss of \$82 in benefits per person per month.
- b.The letter was written by the Tenderloin Neighborhood Development Corporation and SF-Marin Food Bank.

Request \$35 Million to Refund the California Nutrition Incentive Program (CNIP) in FY23-24 [LINK]

a.CNIP is the state program that funds Market Match at farmers' markets. The Market Match Program is currently the single largest CNIP program, administered through CDFA. Market Match is California's largest nutrition incentive program, matching federal nutrition assistance benefits, like CalFresh and WIC, at farmers' markets and other farm-direct sites.

Request \$60 Million to Fully Fund The Local Equitable Access to Food (LEAF) Program [LINK]

a. Request to fully fund the Local Equitable Access to Food (LEAF) Program, which was established under SB907. The LEAF program would expand EBT access at farmers' markets, increase the number of farmers' markets in low-income neighborhoods, and allow farmers' markets to hire full-time staff dedicated to EBT outreach. This is important for our community as we've heard from farmers' market managers that they are having a hard time reaching our monolingual community members because of language barriers. This program could give farmers' markets the resources they need to build out appropriate tools and hire appropriate staff.
